The Kłosek family consists of three people: mother Joanna and her two adult, disabled children, Magdalena and Kamil. The entire family struggles with numerous health issues and a difficult financial situation. Both the mother and the children need constant help from many specialists, medications, access to therapy, and rehabilitation. Unfortunately, the costs exceed their financial capabilities.

Joanna, the family's caregiver, tries to help her children and provide them with everything they need, but she herself faces numerous health problems, including glaucoma in both eyes, asthma, circulatory system disorders, spinal degeneration, emphysema, bladder dysfunction, deformities of the hands and feet, and many other ailments.

Magdalena suffers from atypical autism (with significant communication problems, numerous anxieties, and phobias), moderate intellectual disability, vision problems (strabismus, astigmatism, and hyperopia), numerous endocrine problems, obesity, drug-induced liver damage, allergic rhinitis, gout, hypothyroidism, and cysts in the pineal gland and Rathke's pouch in the pituitary gland. The list of ailments is long; Magdalena is not self-sufficient and needs constant help in daily functioning.

Kamil suffers from Asperger's Syndrome, anxieties and phobias, frequent headaches, vision problems (myopia), asthma, obesity, hypertension, a pineal gland cyst, hyperprolactinemia, and a thymoma in the mediastinum. He is also allergic and still needs help and support from another person in some situations.


