Hi, my name is Karolina and I live with **Ehlers-Danlos syndrome (EDS)**, a rare connective tissue disorder that affects the entire body. Because of this, its symptoms and related conditions involve all body systems. Every day I struggle with pain, mobility problems, frequent sprains and dislocations, and complications such as **pelvic congestion syndrome, POTS** (which causes severe nausea, vomiting, fainting, near-fainting episodes, and other issues), **MVP**, and **deep infiltrating endometriosis**, which damages organs and nerves.

Recently, I was also diagnosed with **heart failure**, which requires many daily adjustments. Along with this diagnosis, I was found to have **ischemic heart disease caused by abnormally narrow arteries**. EDS also affects my digestive system, and complications require **self-catheterization**. I am also on the **autism spectrum**, and I live with **depression and anxiety disorders**.

Despite these challenges, I study online, run a small business, and pursue my passions. Any support will help me cover treatment, rehabilitation, and the purchase of necessary equipment.
